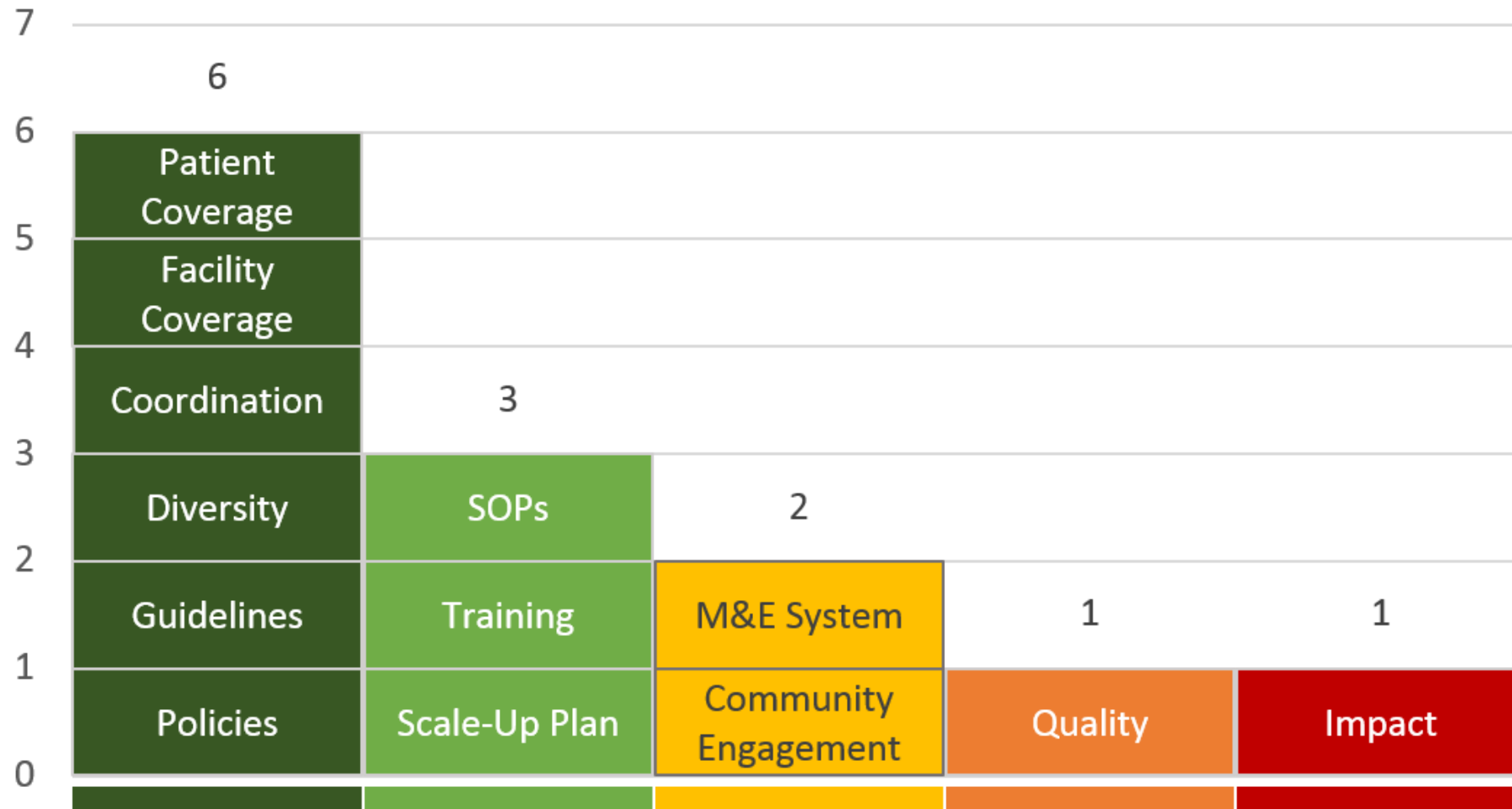

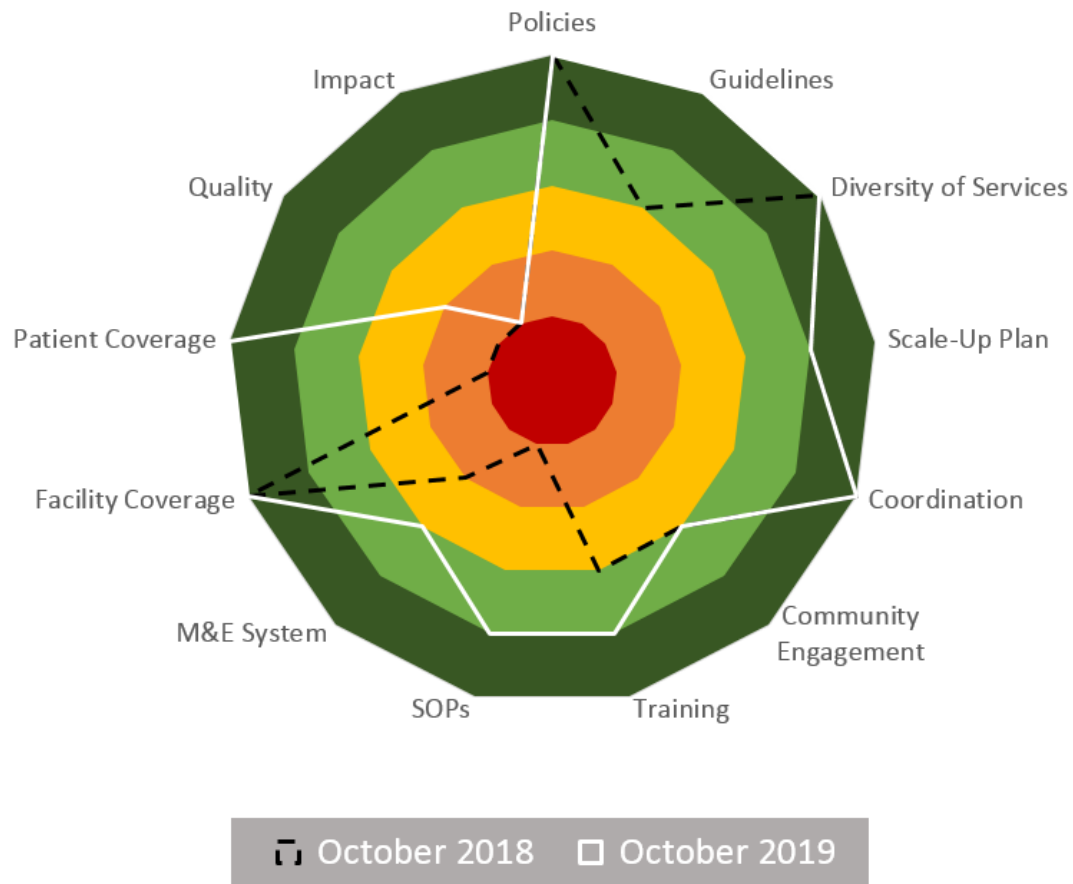

CQUIN Dashboard Results



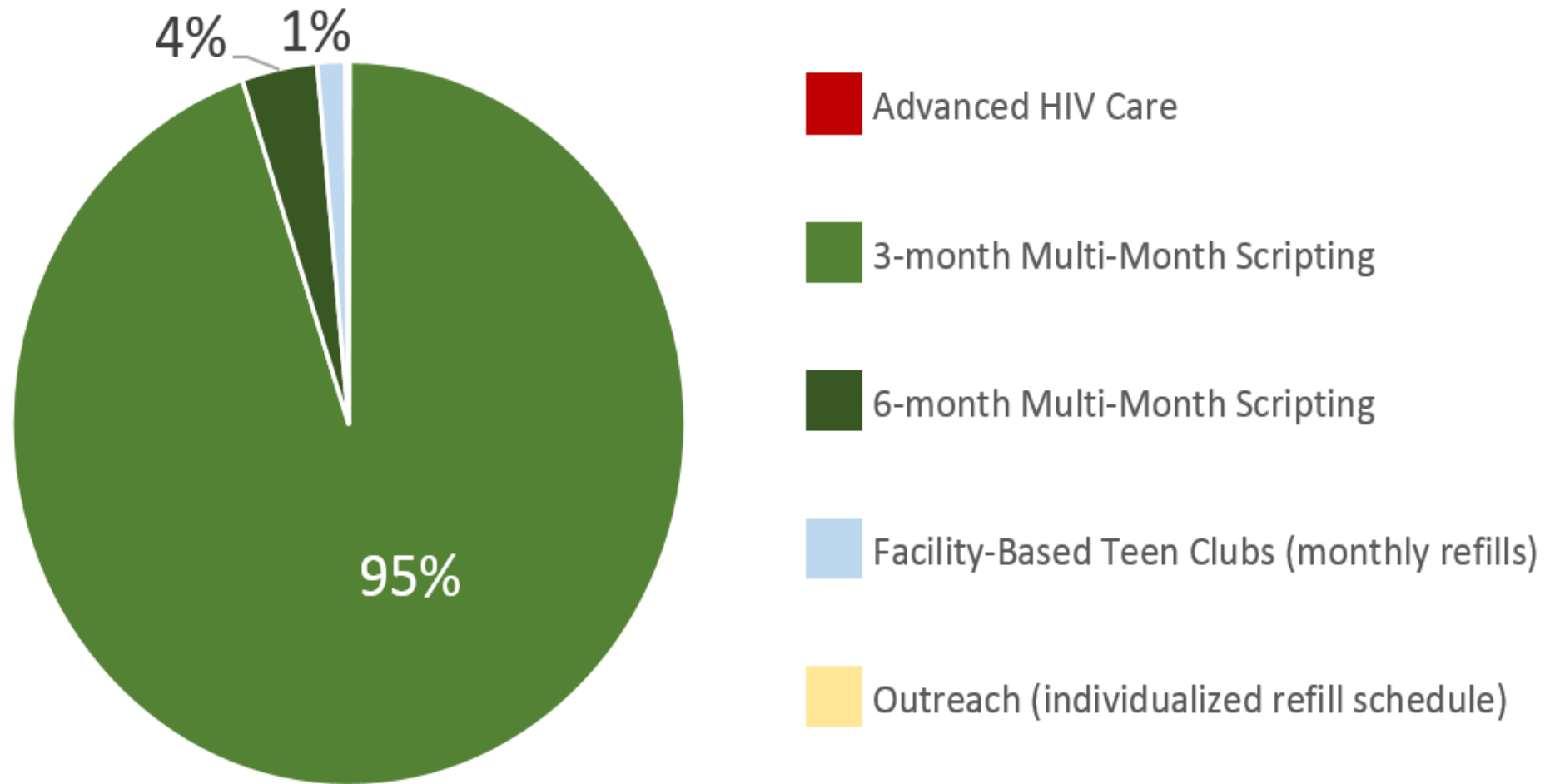
Change in Dashboard Domains since 2018

Update on CQUIN Action Plan from 11/2018

- Activities that have been successfully completed include:
 - Decentralization of less intensive models to peripheral sites
 - Mapping of Implementing Partners to support scale up
 - Quarterly coordination meeting with DSD stakeholders
 - *Progress for scale up of DSD models are discussed*
- One activity that was dropped or that is still underway is:
 - CAGs and FTR not supported by the National Program
 - Both ROC and provider preference is on 6 MMS

Successes-1

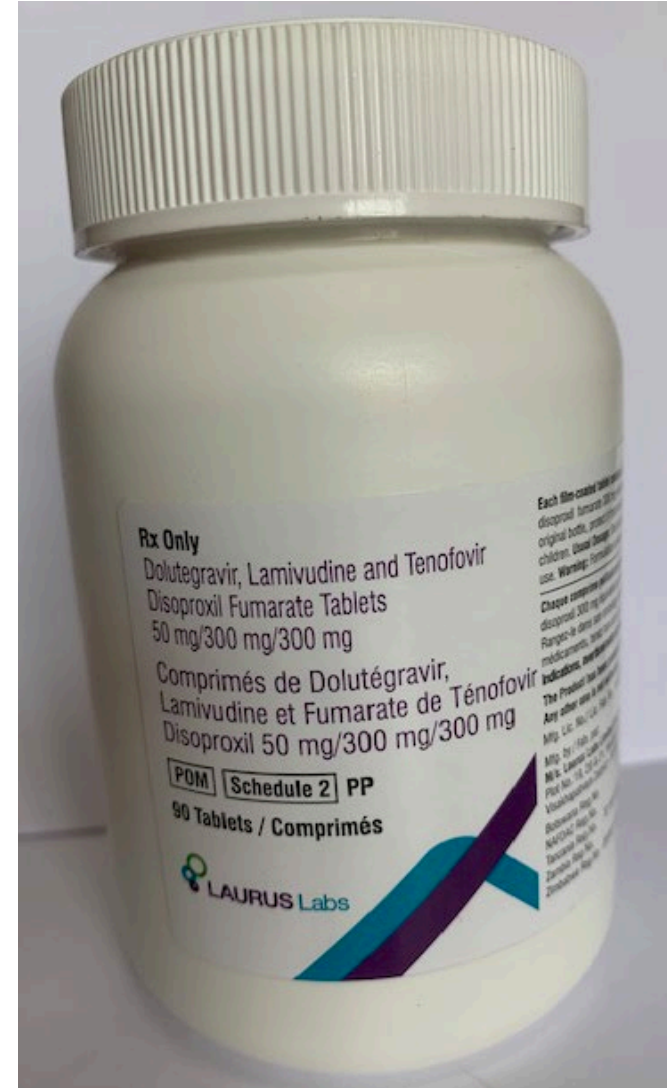
- MoH Senior Management endorsed 6-MMS policy in April 2019
- Policy dissemination done through
 - National HIV Program coordination meeting with DHMTs
 - Providers ART training
- SOP for 6-MMS developed by DSD taskforce and IPs shared to the sites
- Phased implementation of 6-MMS
 - Started with high burden sites with adequate storage capacity
 - 30,000 ROC were transitioned
- High demand from ROCs since its commencement

Successes- 2

➤ Adequate stock availability

☐ TLD 90'- 880,000 Bottles

☐ TLD 30'S – 1,678,101 Bottles



Challenges

- Inadequate storage capacity in other sites not supporting scale up
- Alignment of 6MMS with other services
 - Viral load
 - NCD
 - Family planning
- Monitoring of number of ROC on various DSD is difficult due to various EMR challenges
- Lack of formal evaluations on the impact of DSD models

2020 Goals and Targets

- Country-wide roll-out of 6-MMS
 - Sites with storage space and security
 - Sites with adequate stocks
- 80% of people on ART will be in less-intensive DSD models
- Plans to integrate TB/HIV services into less-intensive models.
- Incorporation of DSD module in EMRs
- Share update on AMBIT project (Assessing Impact, coverage, distribution, costs of DSDs)
