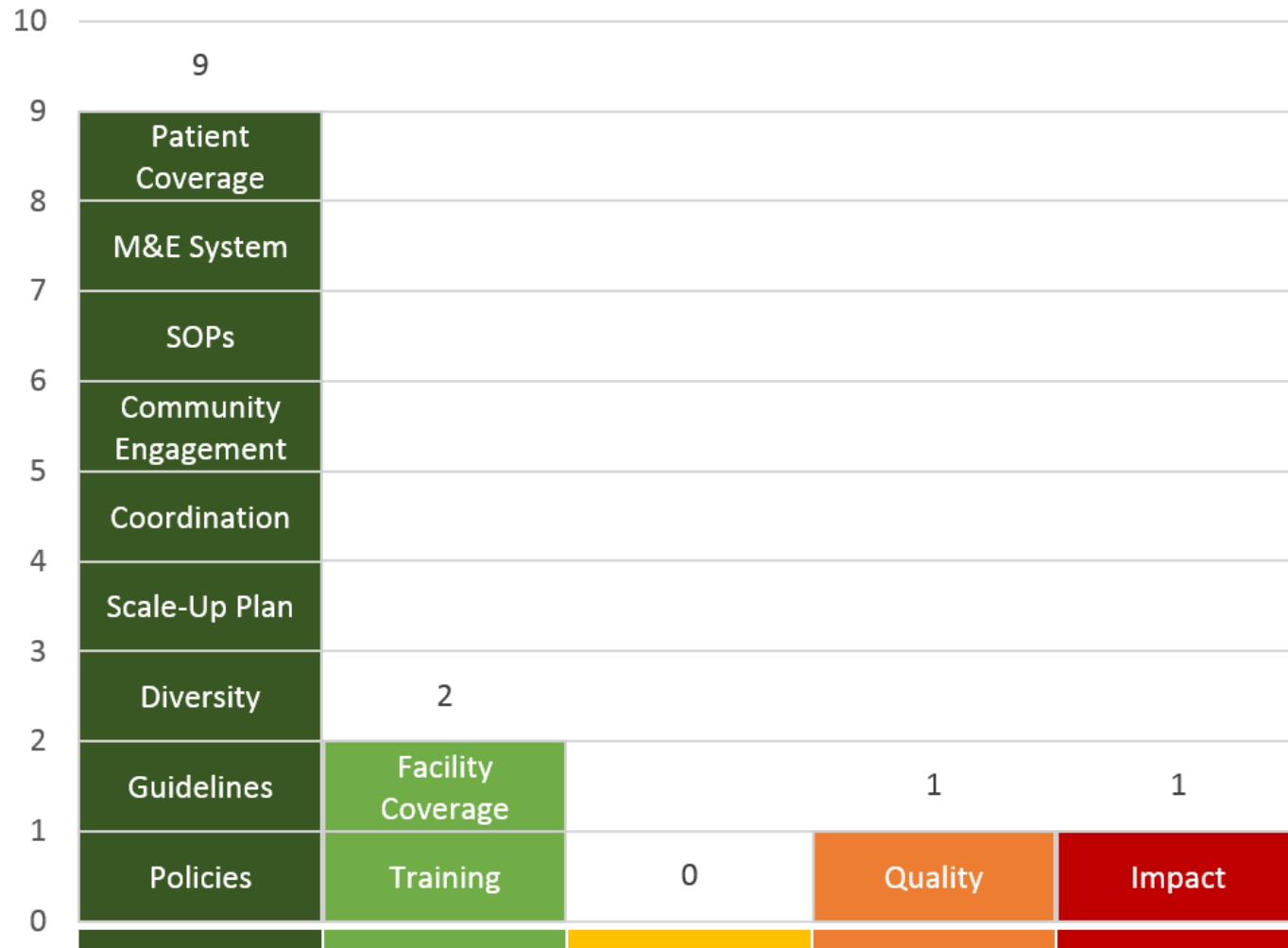

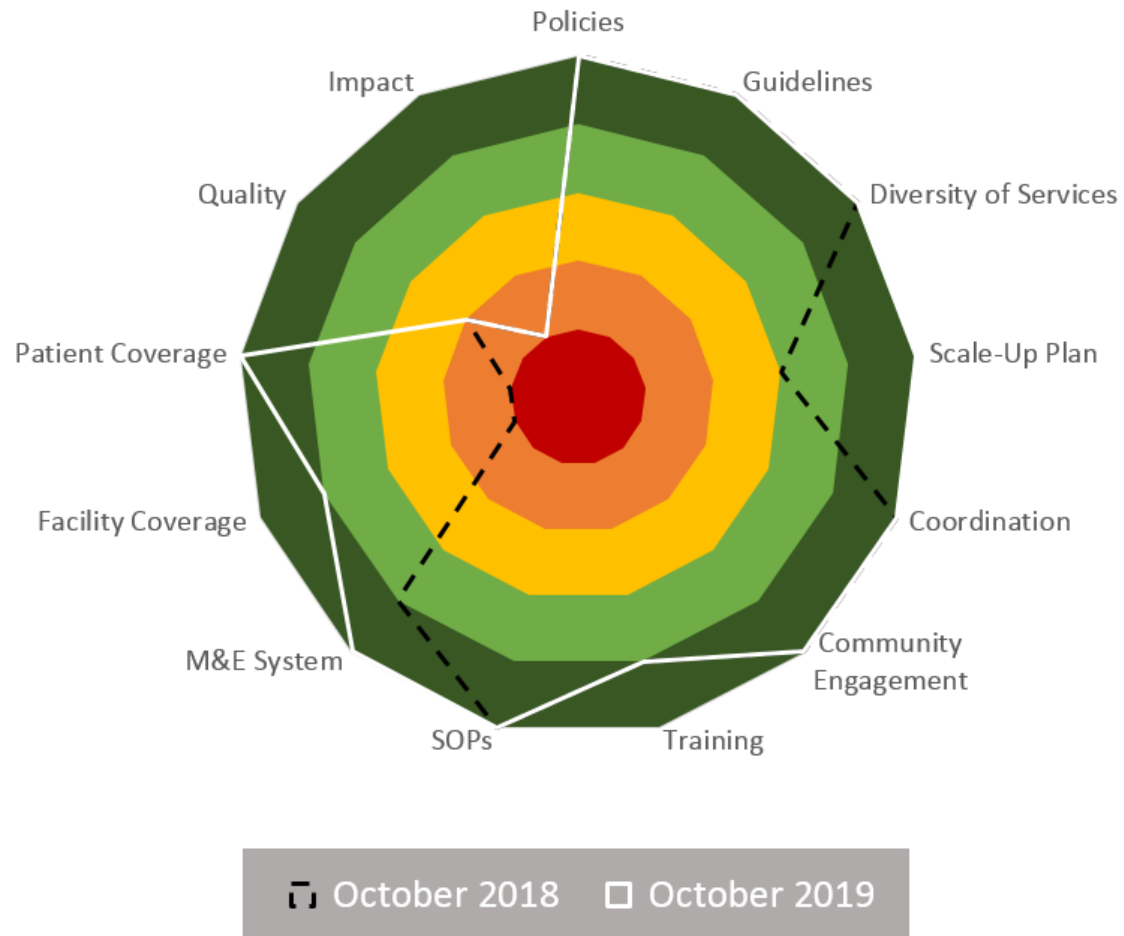

CQUIN Dashboard Results



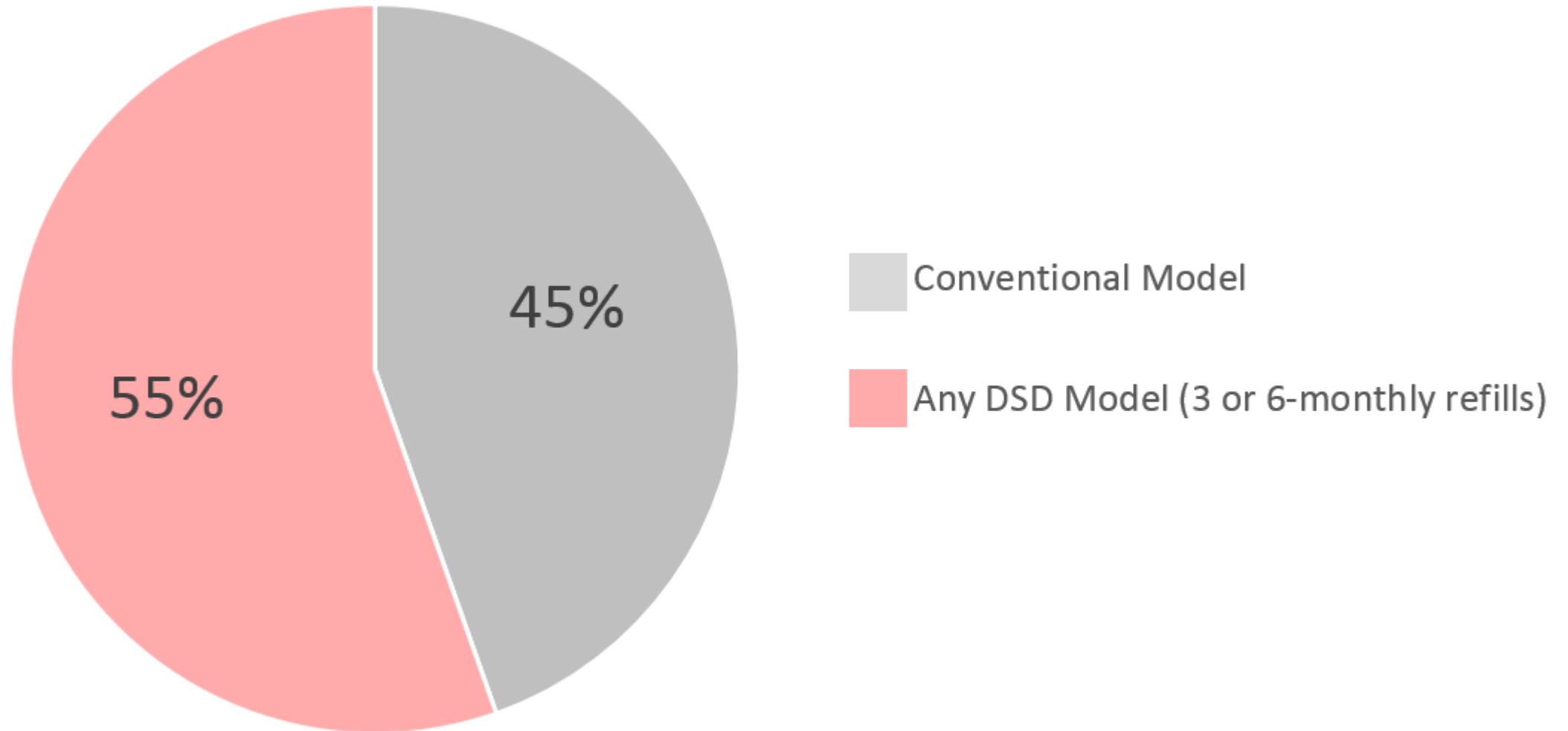
Change in Dashboard Domains since 2018

Update on CQUIN Action Plan from 11/2018

- **Activities that have been successfully completed include:**
 - Development and Integration of Quality DSD standards into Guidelines, Operation manual, DSD implementation plan and support supervision tools
 - Trained on treatment literacy & Scale up PLHIV Empowerment Groups; using generic existing package
 - Strengthening of supportive supervision and mentorship on DSD at facilities with provision of remote TA via WhatsApp to select facilities
- **One activity that is still underway is:**
 - Mapping non-active youth clubs so as to empower them through PLHIV cluster structures
 - Harmonized and standardized National Guideline for Treatment Literacy

Successes (1)

Policy Level

- National DSD Operational Guide finalized and includes targets, indicators (Quality) and M&E plan
- Establishment of National Youth Platform as a way of harmonizing youth participation from various youth networks and maximizing learning opportunities
- M&E tools and Database revised
 - The design can easily accommodate improvements and new updates

Successes (2)

Models of Care

- Improvements in **ART adapted for adolescents**
 - integrated transition to adherence groups, few clusters empowered, scale up ongoing
- Increase in implementation of **MMR**
 - Survey at 60 facilities show 100% uptake of at least one type of MMR model

Challenges

- Uptake in **resource intensive models** remains a challenge:
 - HCW- led community refill models, ART for men and family support models
- **Correct classification of clients** remains an issue
 - Misclassification of clients is a missed opportunity to offer DSD model and support clients who need standard HIV care

2020 Goals and Targets

80% of people on ART will be in less-intensive (3- and 6-month prescriptions) DSD models as follows:

- **75% Facility-Based Pharmacy Refill Model**
- **5% Facility-led Outreach Community Model and**
- **50% Family/ Treatment Supporter Model**

2020 Goals and Targets

- Training and TA to improve data quality and client classification systems
- Share strategies across regions/facilities to identify key approaches to optimize implementation
- Support CQI for DSD at the facility level
- Orient mentors and quality improvement teams on the updated content
