Context


The country continues facing some challenges in providing HIV services:

- Provider's work overload;


As part of the response to these challenges, in 2018, MOH developed and started implementation of the National DSD Guide




Mozambique – model mix, June 2020-21 results *vs.* 2021 targets




Mozambique – model mix, June 2020-21 results *vs.* 2021 targets

Update on CQUIN Action Plan

- Activities that have been successfully completed include:
 - Outcome data measurement in the National QI strategy
 - Conduct DSD data performance review
- One or two activities that were dropped or are still underway include:
 - Update of the National Viral Load Algorithm (being finalized by the TWG)

Items Added to the Action Plan Mid-Year

After The Differentiated MNCH Meeting In May 2021:

- Integrate FP methods in care and treatment clinical consultations for non pregnant HIV positive women at HF
- Implement multi-month drug dispensation for pregnant women in emergency context
- Strengthen the multi-month drug dispensation for BFW
- Integrate VL processing in point of care (POC) existing platforms at facility level (M-Pima and Gene Xpert)
- Create electronic file (on EPTS) to capture information regarding clinical follow-up of exposed child/mom-bay pair until the end of the PMTCT cascade
- Include the integrated FP componentes in the National QI strategy/cycles

Items Added to the Action Plan Mid-Year - 2

After The Differentiated KP Services Meeting:

- Strengthening/scale up of networking for key populations
- Use of digital platforms for demand creation
- Implementation of "safe spaces" and provide testing and linkage services
- Implementation of self testing services for MSM, FSW and Prisoners
- Implementation of Mobile Clinics for key population services

COVID-specific adaptations

Policies adapted in response to COVID19

- Scale up of 3MMD at all health facilities (depending on stock availability)
- Roll out of one stop model at clinical cabinet
- Updated eligibility criteria for 3MMD enrolment
- Inclusion of 3MMD for pregnant women and breastfeeding women (specific cases)
- Roll out of Community Drug Dispensation
- Adaptations that will be sustained beyond COVID19
 - Scale up of 3MMD for all health facilities (depending on stock availability)
 - Roll out of one stop model at clinical cabinet
 - Updated eligibility criteria for 3MMD enrolment



• Roll out/scale up of new DSD in the country

- Community ART Dispensation
- One stop Model at clinical cabinet
- Extended hours
- DSD Performance Review
 - Assessment of Coverage, Quality, impact and Patient/Provider perception
 - DPR Dissemination Meeting









Challenges (other than COVID-19)

- Registration tools only allow registration/reporting of one or two models per patient;
- Health facilities without EMR are not able to report DSD data;
- Quality of services provided to patients on DSD;
- Availability of AHD commodities for implementation of AHD package.

2022 Goals and Targets – 1

By CQUIN's next annual meeting (end-2022):

 85% of people on ART will be in less-intensive DSD treatment models

• Plans for model mix – Gradual scale up of 6MMD

2022 Goals and Targets – 2

- Scale up Self Test and Dual Test (HIV/Syphilis)
- Train Providers and scale up AHD package to 26 health facilities
- Implement 3MMD for pregnant women and breastfeeding women in emergency settings
- 2nd DSD Performance Review
