Change in Dashboard Domains since 2020

- An itemized scale up plan (orange to green)
- Nigeria has finalized its approach to DSD coordination (orange to dark green)
- Facility coverage from light green to red (2020 dashboard was staged using partner's data but 2021 focused on national M&E system)
- Patient coverage from light green to red

Differentiated Treatment Model Mix (Less-Intensive)

Facility-Based Individual Models

- Fast Track
- Decentralization (Hub and Spoke)
- After hours
- Weekend and Public holidays

Facility-Based Group Models

- Facility ART group: HCW-led
- Facility ART group: Support group-led
- Child/Teen/Adolescents club (Peer managed)
- Mother infant pair/Mentor mother led

Community-Based Individual Models

- Community Pharmacy ART refill
- Home delivery
- One Stop Shop for key populations

Community-Based Group Models


- Community ART Refill Group: HCW-led

Differentiated Treatment Model Mix (More-Intensive)


Standard track ART

Update on Nigeria Action Plan

- Activities that have been successfully completed include:
 - DSD Operational Guide & SOPs finalized yet to be printed and disseminated at a national scale for implementation
 - Develop DSD training materials: National DSD Training Tool Kit (Training Slides, Participants/Facilitators Manual and Job Aids) has been finalized and is awaiting printing and dissemination
 - The DSD SI Grant under Global Fund has been approved: APIN, ICAP and SH-24 to support with technical assistance for policy review and adaptations including virtual services to support national implementation.

Update on Nigeria Action Plan (2)

- Activities that are still underway include:
 - Start routine data capturing for clients on DSD:
 National-level routine data capturing to commence after the dissemination of the DSD operational manual (State-level ongoing)
 - National M&E tools have been harmonised to capture 3 programme monitoring indicators for DSD (Awaiting roll-out)
 - DSD Performance Review is ongoing in two states (Federal Capital Territory and Akwa Ibom)

COVID-specific adaptations

Policies adapted in response to COVID-19

- Adaptation of new innovative testing approaches to increase access to HIV testing using HIV Self-Testing (HIVST) to enable social distancing and reduce healthcare burden.
- Development of diagnostic contingency plans and identification of opportunities to decongest health facilities and limit exposure to the novel coronavirus
- Scaling up of multi month dispensing (MMD)
- National HIV Situation room in response to COVID-19

COVID-specific adaptations (2)

COVID-19 related policies adapted that will be sustained beyond COVID-19:

- Modification of new innovative testing approaches to increase access to HIV testing using HIV Self-Testing (HIVST) to enable social distancing and reduce healthcare burden.
- The diagnostic contingency plans developed to decongest health facilities and limit exposure to the novel coronavirus
- Scaling up of multi month dispensing (MMD)

Successes

- DSD Operational Manual finalized
- DSD training slides, facilitators and participants manuals developed
- DSD indicators included in national M&E tools
- Conducted first DSD Performance review in two states
- Contributed to S2S Learning Exchange Liberia and Kenya (Tentative)
