

## 95-95-95 Cascade (status based on SPECTRUM 2022 estimates)






## CQUIN Treatment Capability Maturity Model Staging- Results: Change Over Time







## Country Level Planning and Coordination

- DSD activities planning and coordination meetings are done quarterly through Liberia's DSD TWG.
- There was no meeting held up to the time of this slide's submission.
- The Liberia DSD TWG is closely supervised by the Program Manager of NACP and comprises of the DSD coordinator, Treatment Lead, M&E Lead, QA Lead and the president of the Liberia network of people living with HIV & AIDS (LIBNEP+).
- The TWG meetings include members from the LIBNEP+ and others
   CSO White Rose Alliance (WRA), Stop AIDS In Liberia (SAIL), Liberia
   Women Empowerment Network (LIWEN).



#### **Engagement with CQUIN**

#### In the past year:

- Communities of practice Liberia participated in included: M&E, QI, MCH, TB/HIV, PrEP, dHTS & KP
- Liberia did not participate in any country-to-country visit over the period
- August 8 to 12, 2022:
  - MOH and the CQUIN team visited health facilities and pharmacies involved with decentralized drug distribution (DDD). The visit to these sites was conducted as a CQUIN follow up after Liberia's country-to-country exchange visit to Nigeria on DDD.
  - The CQUIN treatment capability maturity model staging was supported by CQUIN with the Project Director and Regional SI Liaison Officer present during the staging.
  - The CQUIN differentiated HTS (dHTS) capability maturity model pilot staging was also conducted and supported by CQUIN
- Key lesson learnt: Best practice on re-engagement from Malawi and the involvement / training of herbalists and religious leaders in HIV service provision

## Were any activities added to the action plan midyear?

Considerations for the new national guidelines include:

- DSD for pregnant and breastfeeding women and children living with HIV
- Differentiated HTS



#### Successes

- DDD scale-up to 27 community pharmacies (CP) and 7 Health facilities with 627 recipients of care devolved to the CP
- Increase in 6MM uptake from 11% to 27%
- Improvement in supply chain activities there was no stock out of ARVs used for 6MMD
- Establishment of two (2) KP specific DDD outlets
- Also, one CSO partner outlet for ART distribution was established



## Challenges

- Delay in getting funds from the Global fund served as a major setback in implementing lots of the activities planned for this year.
- Change in personnel in the program also served as a challenge, slowing down aspects of HIV programming
- Training of clinicians across the country to help them understand and implement DSD models still not done
