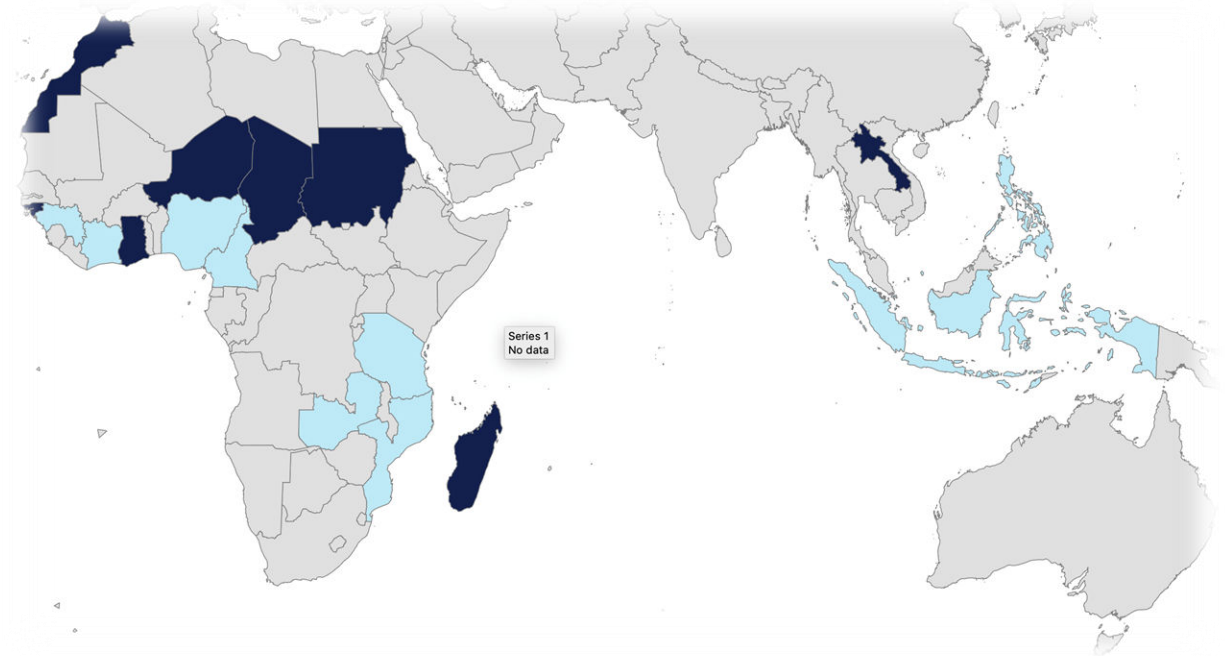
HIV DSD Strategic Initiative

Differentiated Service Delivery(DSD) Strategic Initiative (SI) Objective: The overall catalytic impact of this strategic initiative is to:

1. Drive innovative and ambitious service delivery programming to accelerate progress towards The Global Fund strategic objectives;
2. Enable more effective use of country allocations, accelerating program quality and effectiveness.

The SI aimed to:

- Strengthen the evidence-based implementation and standardization around service delivery approaches,
- Strengthen partnership and engagement around differentiated service delivery approaches and adaptations
- Foster innovative and sustainable approaches to improvement of service quality and efficiency.

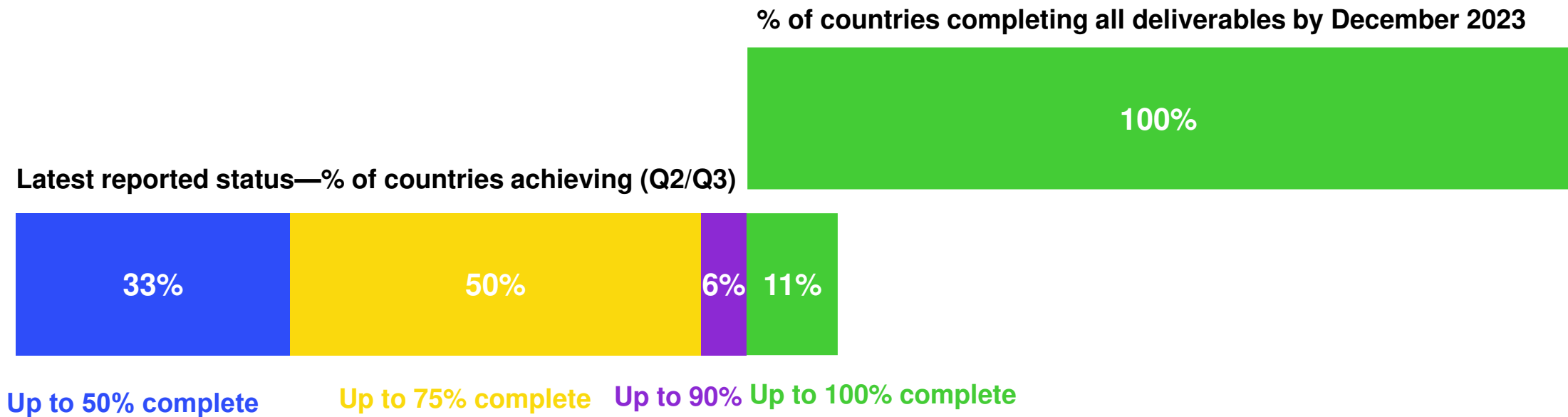


Geographic Focus: Implemented in 18 countries in Africa and Southeast Asia

HIV Prioritized Interventions and Approaches for Global Fund Investments

HIV Prevention	Improving access to and use of precision combination HIV prevention for people at increased risk of HIV infection.
HIV Testing	Deliver a Strategic Mix of Tailored HIV Testing Modalities and Linkage to Prevention or Treatment Services.
HIV Treatment	ART, Treatment Continuity, and Maintaining Health (including coinfections and co-morbidities).
Elimination of Vertical Transmission (PMTCT)	HIV, Syphilis and Hepatitis (aligned to triple elimination initiative).
TB/HIV	Addressing Co-infections.
Strategic Information	Data for Impact.
Human Rights	Remove Human Rights- and Gender-related Barriers to Services.

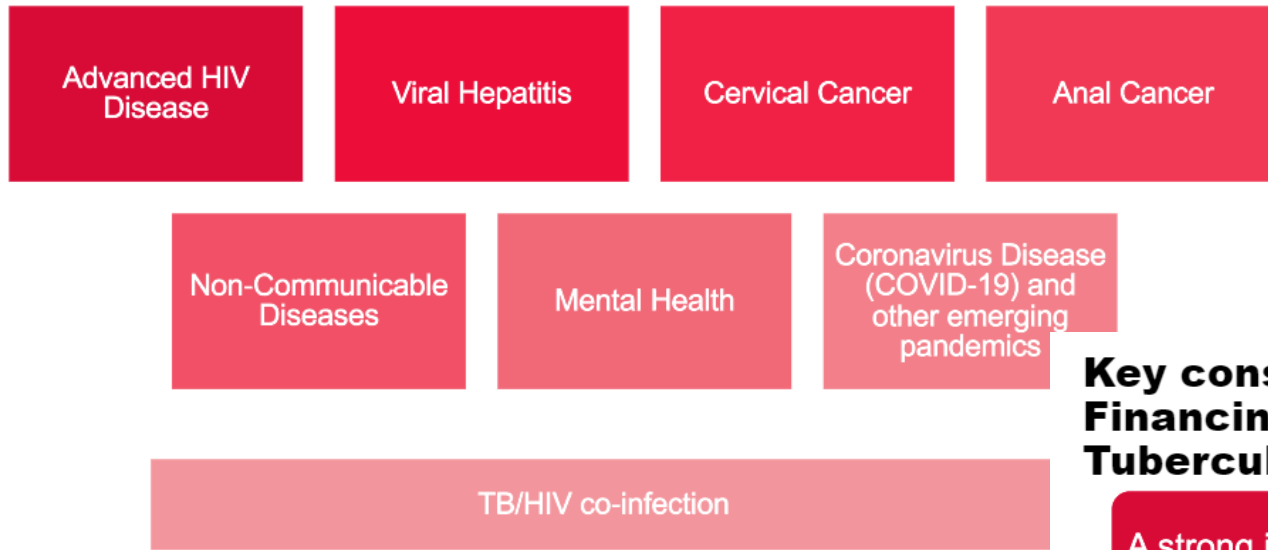

Seven + Priority Areas



Key considerations in addition to the 2015 Framework for Financing Co-infections and Co-Morbidities of HIV/AIDS, Tuberculosis and Malaria (COIM).

A strong investment case.

Proposed interventions reflect integrated people-centered services and approaches.

Proposed interventions leverage HIV service delivery platforms.

Identification of, and alignment with relevant co-financing- domestic and other funders.

- Differentiated services for condom and lubricants
- Sexual and reproductive health services

DSD Considerations in GC7

Differentiated Testing

- **Community-based testing for AGYW and their male sexual partners programs**
- **Community-based testing for KP programs**
- **Community-based testing outside of KP and AGYW programs**
- **Facility-based testing for adolescent girls and young women (AGYW) and their male sexual partners programs**
- **Facility-based testing for key population (KP) programs**
- **Facility-based testing outside of key population (KP) and adolescent girls and young women (AGYW) programs**
- **Self-testing for AGYW and their male sexual partners programs**
- **Self-testing for KP programs**
- **Self-testing outside of KP and AGYW programs**

DSD Considerations in GC7

Treatment, Care and Support

- **Diagnosis and management of advanced disease (adults and children)**
- **HIV treatment and differentiated service delivery - adults (15 and above)**
- **HIV treatment and differentiated service delivery - children (under 15)**
- **Integrated management of common co-infections and co-morbidities (adults and children)**
