

## Status Neutral Testing approach is vital to achieve global HIV targets

#### Test, Identify PLHIV, link and maintain in care

- Identify PLHIV and Initiate them on ART
- Maintain RoC on ART (including reengagement) to attain U=U

#### Test, link to prevention

- Offer voluntary HTS as a vehicle for HIV prevention
- Identify people who test HIV negative and are at ongoing risk of acquiring HIV
- Link and maintain people at risk on effective HIV combination prevention services as long as risk remains

- Timely Linkage to both treatment and prevention ensures early engagement of PLHIV, and people at ongoing risk of acquiring HIV
- Monitoring and Evaluation provides the program with timely information needed for decision making
- Without meaningful community engagement, little can be achieved in the treatment and prevention engagement arms



## Status Neutral Testing: challenges highlighted by CQUIN member countries

#### Webinars:

- 3. HIV self-testing
- 4. Linkage to prevention
- 5. M&E of dHTS
- 6. Target-setting for dHTS
- Country priorities were based on the CMM results, and lessons from the dHTS meeting (March 2023)
- Domains related to Status Neutral Testing were among the top 6 priority areas identified by the CQUIN network countries
- ICAP CQUIN, in collaboration with other stakeholders has provided TA to countries to address the highlighted gaps
