- ✓ Launched in 2017, CQUIN has focused on bridging the gap between policy and implementation at scale

- Ministries of health providing country leadership and strong partnership in a demand-driven approach
- ✓ Strong engagement and support from PEPFAR, CDC, USAID, ITPC, WHO, UNAIDS, Global Fund
- ✓ Active exchange of best practices, innovations, tools and resources, and sharing of common challenges
- ✓ Support from Bill and Melinda Gates Foundation

Increased coverage and quality of differentiated HIV services, leading to enhanced health outcomes and programmatic efficiencies


Increased use of data for decision making

### Maturing of national DSD programs over time



Efforts have resulted in measurable progress, such as a draft for review of achievement of more than 25% progress to a target

- Considerable progress has been made, resulting in over 50% progress to a target or working systems only in need of finalization
- Achievement of a highly-evolved implementation; further improvements and refinements can be made as needed




### Have you attended a CQUIN multicounty meeting before-Virtual or in-person (N=119)







### What is your primary role in DSD Service Delivery (N=120)










## To what extent is TB preventive treatment (TPT) integrated into DSD HIV treatment models in your country? (N=92)





#### To what extent are <u>family planning (FP) services</u> integrated into DSD HIV treatment models in your country? (n=89)




## What are the three most significant barriers to scale-up of integrated TPT and HIV services in your country? (Examples)

- La formation des acteurs, L'enrôlement dans un model, Disponibilité des intrants




## To what extent are services for <u>hypertension (HTN)</u> integrated into DSD HIV treatment models in your country? (N=93)





Is more evidence from research and/or program evaluations needed in order to support policy changes related to differentiated treatment in your country? (N=86)




### If yes, which data do you need in order to optimize DSD treatment policy? (Examples)

## What's next for DSD? What are the priorities or new issues for the coming year in your country or organization/institution?

- Service integration
- Expansion of automated medicine dispensing systems
- Greater involvement of recipients of care
- Provider capacity-building
- Scaling up advanced HIV disease patient management
- Integrating DSD indicators into the DHIS2 database
- Expanding DSD to other populations e.g. PBFW, mobile populations
- Operationalizing the country DSD policies
- Scale up community ART initiation
