- Designed for use by National and State level stakeholders in all levels of health facilities to assess what the facilities already have and what they need to put in place. It may also be used by facility management.
- The results of the assessment help guide facilities in closing gaps in service integration.
- Comes as an Excel and a printable format



### **Assessment Includes...**

- Human resources for health doctors, nurses and other cadres- and the number presently offering HIV services,
- Types of HIV services presently offered and level of integration into mainstream health services, at various delivery points(lab, pharmacy, GOPD, etc)
- The availability of NCD services at the facility,
- Capacity building activities, including the presence of internal trainers, and existing gaps.
- A section on integration thinking, where suggestions are made by the facility staff on the best days/times to integrate service delivery.

IOR AID

- The purpose of the SOP is to describe the process of integrating HIV services into the mainstream health care system of Nigeria at the different levels of care be they private or public), and designed for use by various stakeholders.
- Job Aid is a simple tools specifying the roles and cadres of health care workers to implement service integration, for use at the health facility.
- A page included for service integration for PHCs, as these make up 85% of health facilities in the country.
- Also gives a framework for effective referrals.
- It is intended as a complementary tool to the National HIV Service Integration Manual.



## **Training Manual**

- The training manual is designed to build the capacity of health care workers on care for PLHIV and service integration.
- It covers various aspects of care for RoCs, including adult/pediatric ART, AHD, CQI, and Integration implementation planning.
- Currently ToT has been done for national and state trainers.


